**The penalty for election falsification is imprisonment for up to five years, or a fine not to exceed \$10,000.00 or both.**

**\*\*For Nonpartisans ONLY:** If you wish to vote in this primary election for U.S. Senator and/or U.S. House of Representative, you may request a partisan ballot as stated in §32-912 (2) from one of the political parties by checking the appropriate box. (For the 2018 Primary, the Democratic party has opened their Primary Election to nonpartisans, so their ballot will contain federal, state and county offices. The Nonpartisan Republican and Libertarian ballots will contain only congressional office candidates.)
