Board of Supervisors Meeting – January 4, 2017

The Gage County Board of Supervisors met on January 4, 2017, at 8:46 a.m. with Terry Jurgens, John Hill, Matt Bauman, Myron Dorn, Gary Lytle, Dennis Byars, and Erich Tiemann present.

Notice of said meeting was posted at the County Clerk's Office and published prior to the meeting in compliance with State Statutes.

Let the record show that all proceedings are electronically recorded.

Chairman Dorn announced that a complete copy of the Open Meetings Act is posted at the back of the Board of Supervisors Room.

Chairman Dorn declares the 2016 session formally closed – SINE DIE.

County Clerk Dawn Hill assumed control of the meeting and asked for nominations for Chairman of both the Board of Supervisors and Board of Equalization. Byars nominated Myron Dorn for Chairman, Hill seconded the nomination. The Clerk asked if there were any further nominations for Chairman, there were none. The Clerk said she would entertain a motion to have nominations cease and that Dorn be elected by unanimous ballot.

Motion made by Hill, seconded by Tiemann to cease nominations and elect Myron Dorn as Chairman of the Board of Supervisors and Equalization by unanimous ballot. Motion carried 7-0.

Chairman Dorn asked for nominations for Vice Chairman. Byars nominated Gary Lytle and Tiemann seconded the nomination. The Chairman asked if there were any further nominations for Vice Chairman, there were none. The Chairman said he would entertain a motion to have nominations cease and have Lytle elected as Vice Chairman by unanimous ballot.

Motion made by Byars, seconded by Tiemann to cease nominations and elect Gary Lytle as Vice Chairman of the Board of Supervisors and Equalization by unanimous ballot. Motion carried 7-0.
