Motion made by Tiemann, seconded by Bauman to approve claim #17030338 to Johnny's Welding in the amount of \$70.90, bringing the total amount of claims approved through March 29, 2017 to \$558,667.76. Motion carried 6-0-1 with Jurgens abstaining due to conflict of interest.

No public present for comments or request for future agenda items.

Committee reports were given by Byars and Dave Jones on Building & Grounds/Winter Lights, Jurgens on Finance/Insurance, and Sheriff Gustafson on Law Enforcement/Emergency Management. Break in committee reports for timed agenda item.

Veterans Service Officer Phil Dittbrenner introduced the March Veteran's Honor Award Recipient, Arnold Evers, to the board. Evers served in the U.S. Army from January 12, 1953 to November 23, 1954, and was with Battery A of the 52nd Field Artillery Battalion. Dittbrenner said that Evers has been an asset to the community and has worked tirelessly transporting veterans wherever they need to go. Dittbrenner also presented Evers with a gift certificate to the Legion Club from the American Legion Riders. Evers spoke of the many difficulties of dealing with war, the terrible conditions they endured, and some of the horrifying things he witnessed. He gave credit to his wife Darlene for being the reason he was able to get through each day, stating that she's the one who brought him home. Receiving her many letters is what kept him going through very difficult days. He honored her by having her stand to be recognized with him and gave her a plant to show her his gratitude for her love and dedication to standing by him. Evers went on to say that people need to know how blessed they are to live in America and that if you see someone in need you should give them a hand. Honors received by Evers include the Korean Service Medal, United Nations Service Medal, National Defense Service Medal,

Republic of Korea Presidential Unit Citation, and Good Conduct Medal. Upon discharge Evers transferred to the Army Reserve to complete 8 years of service under the Universal Training & Service Act.
