

NOTICE OF GENERAL ELECTION

Notice is hereby given, that on Tuesday, the 3rd day of November, 2020, at the usual polling places in the precincts of Gage County, Nebraska, an election will be held. The polls will open at 8:00 o'clock a.m. and close at 8:00 o'clock p.m. Said election will be for electing candidates to various offices. Some races will not appear on your General Election ballot as the candidates are elected by specific subdivisions, districts or wards. At such election voters may accept or reject statewide constitutional amendments or referendums. The Secretary of State will publish a true copy of the title and text of any amendments or referendums once each week for three consecutive weeks preceding the election.
