During the committee reports, Dave Jones had Winter Lights Committee member Steph Perkins bring Chairman J.T. Thornburg up to talk about his idea of lighting the courthouse, how it became a reality, and how much the support of the board and the community has played a part in keeping the vision going for 32 years. Steph stated that J.T. would be stepping down as Chairman of the Winter Lights Committee but would still act as a consultant, and she thanked him for his passion for the project and his many years of dedication in seeing it through each year. She also presented him with a picture of the lighted courthouse and a plaque commemorating his years of service on the committee. J.T. said he was humbled and thanked Steph, the committee, and the Board of Supervisors for the recognition and for their support in helping make his idea become a reality.

Discussion on the agenda item regarding a resolution to continue to provide for the lawful constitutional right of the Election of a County Surveyor by the registered voters of the County of Gage, Nebraska, but no motion was made to approve or disapprove the resolution. Therefore, the question of the County Surveyor being an elected position will be placed on the ballot to be voted on by the voters of Gage County.

Jerad Reimers presented a Washington update from Congressman Adrian Smith to the board.
