Motion made by Lytle, seconded by Dorn to approve the consent agenda. Motion carried 7-0.

Motion made by Swavely, seconded by Dorn to approve claim #24010229 to Hard Rock Quarry in the amount of \$2,504.72, bringing the total amount of claims paid through January 24, 2024 to \$921,734.37. Motion carried 6-0-1 with Tiemann abstaining due to conflict of interest.

Margaret Haith, 104 W Granville Ave., Beatrice NE spoke under public comments regarding the smell from CAFO's and the current ½ mile setback not being far enough, would like it to be changed.

Committee reports were given by Swavely on Bldg. & Grounds, Tiemann on Equalization, Jurgens on Finance/Insurance, and Shf Gustafson on Law Enforcement. Break in committee reports for a timed agenda item.

Motion made by Swavely, seconded by Dorn to open public hearing at 9:16 a.m. to hear support and/or opposition from the public on Special Use Permit #2023-6 for the placement of a Telecommunications Tower to be located on a tract of land in the NE corner of the North $\frac{1}{2}$ of the West $\frac{1}{2}$ of Section 6 in Blakely Township, Gage County, Nebraska. Motion carried 7-0.

P&Z Administrator Lisa Wiegand gave the P&Z's recommendation of approval of the SUP. She discussed the location being on Cammack's ground near Tri County School, notices that were given, P&Z's public hearing was held, distance from tower to nearby residences, that all requirements were met, and that the P&Z Commission recommends approval with the condition that during the construction phase, Elm Road is maintained at the current condition or better, which the permit holder has agreed to. Jerrod Foutes, 4714 W 80th St., Prairie Village KS, said that he represents Horvath Communications who will be the owner and Verizon who will be the main tenant, and that in the permit process it is agreed that tower space will be provided to the county for 911 use. He also stated that the tower meets all FAA requirements.

Motion made by Dorn, seconded by Swavely to close public hearing at 9:33 a.m. Motion carried 7-0.

Back to committee reports – Lisa Wiegand on Emergency Management & P&Z, and Haxby on Road & Bridge. Topics of discussion during all committee reports included repairs needed for Shf phone backup; introduction of Wymore Police Chief Bobby Martinez who came from Cheyenne County; issues with Shf. hybrid vehicle; next P&Z meeting is on Feb. 22nd at 7:00 p.m.,

with public hearing on SUP for commercial ag business; sub-committee of Haxby, Swavely and Dorn to re-review zoning regs changes to recommend to P&Z, public should contact one of the 3 with ideas; public welcome to give input at the Feb. 5th committee meetings at 8:00 a.m. on livestock regs and setbacks; Marcella Rademacher spoke and provided documentation of odor issues with the CAFO in Hanover Twp., stating she lives 1 mile west and ½ mile north and the smell is constant, the vents and incinerator are running at all times, said Brandon Oltman on Buckeye Rd nearby had someone driving by stop at his residence because they could smell what they thought was propane but it was actually the incinerator, Laura Fikar who lives SE of facility sent Marcella a message this morning that said the smell was terrible, maybe the Supervisors should go for a drive today, Kevin & Kristen Meyer has said the smell is all the time and even coming into their house, a group has gone to NDEE and all they say is that odor is subjective, she says the value of her place has plummeted because no one wants to live with that; Haxby thanked Hwy crews for work with snow removal; Township Association Annual Meeting will be on Feb. 8, 2024 at 7:00 p.m. at the Veterans Club with infrastructure outreach included; and discussion on grants in process.
